### **RULES & REGULATIONS FOR DIRT BIKER RACE**

#### **Technical/Safety**

- i. All participating Dirt Bikes must pass technical/safety inspection on the following points prior to the Race.
- ii. **Protective Gears are MANDATORY** for all Dirt Bikers.
- iii. Dirt Bikers Uniform (Protective clothing/suit/jacket/ pants/Coverall) are MANDATORY.
- iv. All loose items of Bike must be removed. Any item carried on the Bike must be bolted or securely fastened.
- v. Wheels must be safely affixed.
- vi. Tyres must be in good condition, with no cord or belts showing or cracks in the tread of sidewall.
- vii. Throttle return action shall be safe and positive.
- viii. No fuel, oil, or brake fluid leaks should be observed when the engine is running.
- ix. No cracks shall be permitted in cast or forged wheels.
- x. Brakes must have an adequate pedal, sufficient fluid in the master cylinder and no apparent leaks under pressure and must operate on all wheels.
- xi. Wheel bearings, shocks, and Handle shall be in good operating condition.

#### **General Rules/ Conduct of the Event**

- i. All Bikers should be above 18 years or above and have driving license
- ii. All Bikers shall submit Registration Form with the signature of their parents /guardian
- iii. All participants must consciously display good sportsmanship and a genuine concern for safety. Failure to do so or failure to obey official instructions will lead to disqualification / removal from the rally.
- iv. On Race route, Bikers wishing to overtake must be allowed a safe opportunity to overtake at the earliest.
- v. Helmets and protective gears must be worn at all times while competing on the rally route.
- vi. Mobile as well as stationery officials will be placed all along the rally route to observe rally vehicles.
- vii. Repairs and service of rally Dirt Bikes is freely allowed throughout the rally route, however, participants must ensure that the rally route is not obstructed in any manner.
- viii. Any delay caused by mechanical failure, Bikers error, mishap, Trespassing or whether etc. will be the sole responsibility of the participant and no allowance of any sort will be permitted.
- ix. Any accidents / mishaps must be immediately reported to the nearest rally official/Check point.
- x. The organizers reserve the right to delete, add, or change any part of the route or event regulations at any time should they deem fit.
- xi. The rally will use the 24-hour format for Time management.
- xii. Further rules will be shared with registered participants.

#### **Penalties**

At the start of Rally, any Dirt Bike reporting late for the start of the event will be penalized @ 10 Seconds for every minute that it is behind its scheduled time. Any Dirt Bike arriving at lineup for more than 30 minutes late shall be disqualified. Penalties may be enforced to all those who shall fail to follow the announced Route/Track and deviate beyond the limits announced by the organizers .The decision of the Organizers shall be final and cannot be argued/challenged.

Disqualification will occur in the following cases:

- i. Failure to obey official instructions. \*
- ii. Obstructing overtaking Bikes or dangerous driving practices. \*
- iii. Failure to wear helmets at any point during the race. \*
- iv. Unsafe operating condition of Race Dirt Bike. \*
- v. Use of ethanol/Alcoholic drinks

\*The penalty for these infringements may be reduced from total disqualification to a time penalty of 15minutes at the discretion of organizers.

Tourism Development Corporation of Punjab (TDCP), and its related/affiliated bodies, Organizers, Officials, Directors, Officers and Fellow Bikers, harmless from and against all claims, demands, actions, causes of actions and/or suit s which may be brought and/or made on account of and/or by reason of any injury, damage and/or suffering inflicted regardless of negligence. TDCP has right to reject or accept any registration. Participant/s will accept the decision of organizers/jury and I/we will not pursue in the court of Law.
